GB Tax Exemption Children between 02 – 12 years & Youth passengers between 12 – 16 years

Dear Agent,

Please be guided on following changes on GB TAX for children below 12 years & young Passengers below 16years.

- Effective from 01-May-2015, children under 12 years of age are exempt in the Economy cabin from the GB tax for travel from 01-May-15.
- Effective for travel on/after 01-Mar-2016, the exemption of GB tax will be extended to passengers' under 16 years of age in the Economy cabin for travel from 01-Mar-16.

NOTES:

- **GB TAX exemption applies to Domestic and International sectors when departing from the first UK Airport.**
- The age of the passenger determines the exemption based on the departure date from the first UK airport.
- Passengers may not qualify for a discounted child ticket fare, but however will be exempted from the GB Tax.
- Passengers up to and including the age of 15 years are not subject to the GB tax when traveling in the Economy cabin (excluding Premium Economy).

Booking File creation steps

Add the PNR name remark field with the age and the date of birth (DOB) of the child, in order to ensure the airline is aware that a passenger is under 16 years and therefore qualifies for the automated GB tax exemption.

The young passenger age between 12-16 years old is subject to paying the applicable adult fare but is exempted from paying the GB tax.

You may use PTC's of ITX, STU, YTH for ages 12-15 Yrs. (i.e: YTH14 DOB15MAY01)
